TO WHOM IT MAY CONCERN:

YRC submits this letter in response to your recent request for certain compliance-related information pertaining to, among other things, YRC's status as an equal opportunity and affirmative action employer.

As you may or may not know, for many years federal regulations required that all prime contractors and covered subcontractors prepare and file written certifications stating they did not and would not maintain "segregated" facilities. However, as a result of 1997 amendments to the Office of Federal Contract Compliance Programs' (OFCCP) affirmative action enforcement regulations, these so-called "non-segregated facility" certification forms no longer are required. 41 C.F.R. § 60-1.8; see also 62 Fed. Reg. 44174, 44177 (August 19, 1997).

In addition, in late 2000 the OFCCP revised its regulations governing the content of affirmative action programs (AAP) for women and minorities to eliminate the formal requirement that contractors externally disseminate to vendors and subcontractors their equal employment opportunity and affirmative action policies. 65 Fed. Reg. 68021 (November 13, 2000). While YRC understands that OFCCP regulations governing AAPs for covered veterans and individuals with disabilities still contain the requirement to externally disseminate these policies, these regulations merely suggest – as opposed to mandate – that such written notification be provided to vendors and subcontractors. 41 C.F.R § 60-250.44(f)(6) and 41 C.F.R. §60-741.44(f)(5).

That said, YRC takes this opportunity to certify (for your records) that it indeed is a federal contractor and that it has developed equal employment opportunity and written affirmative action policies and programs to comply with regulations governing federal contractors. We also certify that we do not and will not maintain facilities segregated on the basis of race, color, religion, sex or national origin in any manner that does not comply with federal regulations at 41 C.F.R. § 60-1.8. YRC does not qualify as a minority-owned, women-owned or disadvantaged business enterprise.
